Chair Report – 2013/2014 Financial Year

Presented to the attendees of the 2014 AGM, 17th September 2014

At a state committee level, there have been several notable activities over the financial year starting with in July with both a visit to the Perth Arena and a workshop on the State Planning Policy on road and rail noise.

After the State Seminar in October, we arranged presentations by Professor Gary Evans of Cornell University on chronic stress and noise in children, which included some media coverage in the West Australian and a peak-hour interview on 6PR. This year we have investigated into ways of increasing our brand awareness and held another technical meeting from Fantech.

Overall the sentiment is that member participation is 'business as usual', and we must continue to actively look for opportunities in Western Australia to improve the aims of the Society, even those which may involve significant increases in our spending.

The WA Division continues to offer grants to those in research and development; this year we have increased the available travel grants from \$500 to a minimum of \$750 and a pool of \$3,000 for students presenting at the 2014 conference, along with a \$1,000 prize for best undergraduate project in acoustics and/or vibration completed at a WA tertiary institution this year.

I wish to thank the committee members, past and present, for their valuable contributions over the year.


