5. Awards and Grants

In 2015, the NSW Division awarded NSW Division Travel Awards to six AAS members to attend the Acoustics Hunter Valley 2015 conference. The amount of each award and the recipient are shown below:

The award is to be spent on conference registration fees, travel to and from the conference venue, and accommodation. The successful awardees will provide a short report (200 to 500 words) on their experiences at the Conference to be included in Acoustics Australia journal.

It is important to encourage Student Membership through initiatives such as the AAS NSW Acoustics Prize to the best undergraduate students in acoustics. AAS NSW Division provide university awards in acoustic to the University of Western Sydney, Macquarie University, Sydney University and University of NSW. Each award consists of a cash prize of \$250 and one year's subscription to the Australian Acoustical Society. The objectives of this education prize are to encourage undergraduate students into the field of acoustics and provide exposure for the Society at the university prize giving ceremonies.

6. ACT Division Activities for 2014-2015 - Meetings

The ACT has had a three technical meetings this year, namely:

- The 91st meeting was held on 18 March 2015. It was attended by a small (8) but keen group of AAS members. Jamie Hladky from SLR consulting lead a discussion on acoustic considerations and theater seating based on experiences with the replacement seating for the Canberra Playhouse. The following group discussion extended beyond theatres to other issues of concern regarding the approach to planning and noise control in the ACT.
- The 92nd meeting was held on 16 April 2015. It was attended by a small (8) but keen group of AAS members and guests. Mark Latimore from Airservices Australia explained the role of Airservices in the area of noise. This included the current noise and flight path monitoring system, the updated standards and guidelines, NASAG and some current Airservices projects. We were all impressed by the graphic representations that are now developed and used to better understand the impact of aircraft noise and in the community consultation. An outcome from this meeting is that the ACT Branch of the Royal Aeronautical Society invited Mark and

colleagues from Air Services to present a similar session to one of their branch meetings. This is a particularly active group and the attendance at their meetings is usually around 40.

The 93 rd meeting was held on 15 October 2015. It was attended by a small (7) but keen group of AAS members and guest. Adams Hall is a major raked floor meeting space for 1200 (which can be divided 800/400) with large foyer and smaller break out rooms, which has recently been completed on the ADFA campus. Jerremy Lofts from Rudds was involved with controlling the building services noise and Tim Kuschel from GuzBox was involved with aspects of the audio system. We first met at the venue for a walk around and to see some of the key features. The group reconvened in a separate meeting room and Jerremy and Tim explained the challenges they faced. Both had been called in after design and the construction had commenced. Controlling the services from the plant room under the seating area required substantial additional construction. He also pointed out that a 'whispering gallery' has been created by the curved foyer at the upper level. Tim explained the final selection of suitable microphones and install for the delegate system used in the 400 seat configuration. This system provides a separate microphone at every seat and combined with the presenter software control allows for discussion between the audience and those on stage

In recognition of the role that the coal industry has played in making Australia the world leader in managing noise and vibration generated on mining sites, there will be a dedicated session on mining noise and a chance to visit an open cut coal mine.

The entire NSW Divisional Committee has been working hard to make this conference successful. However, I would particularly like to thank Jeff Parnell the conference chair, Nicole Kessissoglou and Con Doolan for all their hard work.
