the deposit will be refunded in full. If guests cancel inside the 14 days prior to their reservation, the deposit will be forfeited.



Attractions

Fine historic buildings and the fascinating Bollards on Geelong's foreshore are features of the second largest city in Victoria. Award-winning wineries, excellent golf courses and beautiful beaches are all within short drives from the conference facility.

Geelong is the gateway to the Great Ocean Road which leads through Lorne to the stunning Twelve Apostles. Glorious at dusk and dawn these giant rock stacks are a central feature of the spectacular Port Campbell National Park. Created by the forces of nature, gradually eroding the softer limestone, forming caves in the cliffs which became arches and when they collapsed, rock islands as high as 45 meters were left isolated from the shore.

Inland attractions include the temperate rainforests of the Otway region and the fascinating Otway Fly, the world's longest and highest treetop walk.

In addition to joining us for the Conference, you should also consider allowing time to visit the region.

Location

The Conference will be held in the Deakin Management Centre, a world class conference facility, located in the grounds of Deakin University, about 10 minutes drive from the City of Geelong and 20 minutes from Avalon airport.

All three lecture rooms are equipped with the latest technology for presentation of the papers, while the surroundings provide space for relaxation between talks.

Duration
