NOTICE OF 2010 ANNUAL GENERAL MEETING AND TECHNICAL PRESENTATION

The 38th Annual General Meeting (AGM) of the WA Division of the Australian Acoustical Society will be held on Wednesday the 20th October at the Cove Restaurant, 568 Canning Hwy, Attadale.

All parties are welcome to join us for dinner from **6:30pm**, to which the subsidised cost is \$20 per member (\$40 per non-member) plus drinks. No cost for those attending only the AGM and meeting following.

The AGM will commence at 7:30pm, with a technical presentation by Mr Bradley Walsh as follows:

A study into the blade interaction noise of the Mupod

The Mupod is a Micro Unmanned Aerial Vehicle (UAV) developed by Entecho. With VTOL capability, stable hovering and low noise thanks to electric motors, the Mupod is ideal for many UAV situations. At 6kg and one quarter the size of the Entecho Hoverpod, it may be easily transported and deployed anywhere.

Mr Bradley Walsh will provide a short presentation on acoustic engineering aspects behind the Mupod.

The blade passing event of the Mupod radial-flow fan was modelled pseudo-statically in a wind tunnel. Flush-mounted microphones measured the change in surface pressure responsible for the far-field blade interaction noise seen in field measurements. The results explained why the stator with angled blades could significantly reduce the blade passing noise of the Mupod.
